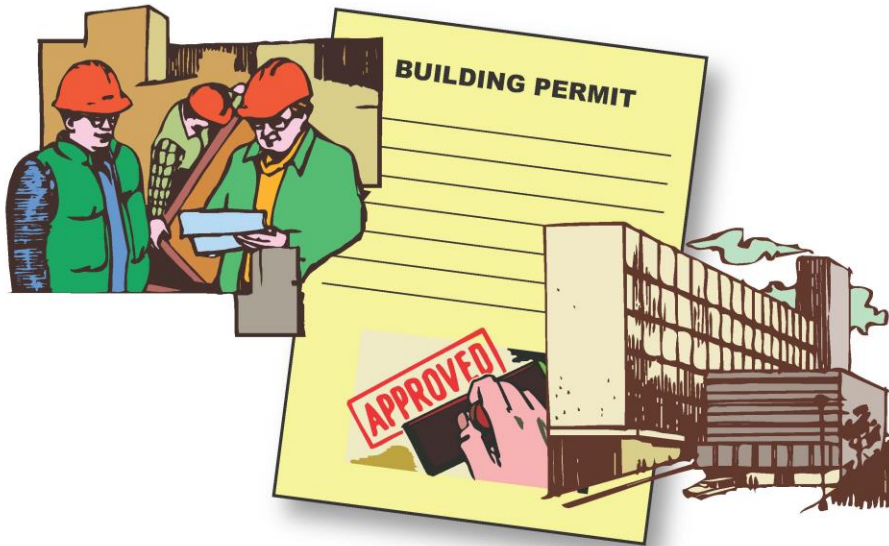

Introduction

Lackawanna County is a great place to work and live, with an excellent quality of life. Lackawanna County offers easy access to major interstate highways, rail lines, an international airport, award-winning education and qualified workforce programs. Lackawanna County's healthy economic environment, competitive business community, exceptional quality of life and attractive financial incentives are perfect conditions for companies looking to expand or relocate.

This program is available to companies relocating to or expanding in Lackawanna County. This waiver is awarded on a case-by-case basis depending on the type of company, number of jobs created, wages, physical or geographical location, and capital investment.

Target Industries

- Advanced Manufacturing;
- Headquarters and Professional Services;
- Health Sciences, Biosciences and Services;
- Information Technology Solutions; and
- Logistics and Supply Chain Management.

Lackawanna County's land development and construction fee waiver program may waive a portion or all of the following permits and fees:

- municipal land development review fees reimbursement;
- municipal zoning and UCC building permit fees reimbursement;
- PennDOT Highway Occupancy Permit or municipal Driveway Permit fee reimbursement (whichever is applicable);
- municipal variance, special exception, or conditional use zoning hearing fees reimbursement (if a hearing is necessary);
- state environmental protection permit fees reimbursement;
- waiver of all county review agency fees (Planning Commission, Conservation District, Engineering)

Eligibility

A business is eligible for this program so long as the business creates at least ten (10) new, full-time, permanent jobs on site within twenty-four (24) months of this application's approval.

Procedure for Program Consideration

To take advantage of this program, a business must submit the application packet to the Lackawanna County Department of Economic Development.

Type of Funding

Funding provided through this program will be reimbursable to the applicant, upon submission of copies of all municipal and state approvals; permits; and itemized receipts of fees paid, documented and signed by the appropriate municipal or state agency. This funding is available only to businesses located in or locating to Lackawanna County.

Application Packet

Two (2) copies of the application packet, containing original signatures, must be submitted.

The packet must include the following documentation:

- Completed and signed Application Form LC-LDCFWP-1 (3 pages).
- Project description
- Resolution authorizing the applicant to apply for program funds and agreeing to the "Terms and Conditions of the Program."

Selection Criteria for Applications

The Lackawanna County Department of Economic Development will manage this program and will evaluate the applications. Funding recipients will be chosen based upon the clearly demonstrated compliance with eligibility requirements and the overall economic impact on

the county. The amount of reimbursement will be based upon the number of full-time jobs created, combined with the positive financial impact in Lackawanna County.

PROGRAM TERMS AND CONDITIONS

We suggest that your legal counsel review the terms and conditions in this section before you submit an application for the land development and construction fee waiver program. They are mandatory for all businesses awarded an incentive through this program and are not negotiable.

If the business is selected for this program, the TERMS AND CONDITIONS OF LAND DEVELOPMENT & CONSTRUCTION FEE WAIVER PROGRAM in this section will be incorporated into the Agreement, and SECTION 6. CERTIFICATION & ACCEPTANCE included in this application package (Page 7) will become the signature page for the Agreement.

TERMS AND CONDITIONS OF BUSINESS INCENTIVE PROGRAM

“COUNTY” in the terms and conditions below means the Board of Commissioners of Lackawanna County. “GRANTEE” means a Business that has been awarded the waiver/reimbursements of the fees associated with land development approval and building/zoning permits and hearings.

ARTICLE I

REIMBURSEMENT AMOUNT

Subject to the availability of funds, the COUNTY makes available to the GRANTEE a check in the amount of \$_____ for the reimbursement of state and/or local development review approvals and issuance of required state and/or local permits associated with the development approval and construction. THE GRANTEE shall provide the COUNTY copies of all municipal and state approvals; permits; and itemized receipts of fees paid, documented and signed by the appropriate municipal or state agency, prior to the approval of payment by the COUNTY.

ARTICLE II
EXECUTION OF AGREEMENT

This AGREEMENT is not binding on the COUNTY until it has been properly executed by all required signatories for the COUNTY. Any cost incurred by the GRANTEE prior to such execution is incurred at the GRANTEE'S risk.

ARTICLE III
COMPLIANCE WITH APPLICABLE FEDERAL, STATE, AND LOCAL LAWS

The GRANTEE shall comply with all applicable federal and state statutes and regulations and local ordinances pertaining to the business construction and activities.

ARTICLE IV
PAYMENTS

The COUNTY will issue a payment to the GRANTEE based upon the COUNTY'S determination of the economic impact and benefit of the project in Lackawanna County.

The COUNTY will not be liable for any expenditure by the GRANTEE that is not a fee associated with a state and/or local agency for the purpose of obtaining land development approval and/or issuance of permits associated with project construction, or for costs exceeding the amount stated in this AGREEMENT.

ARTICLE V
PROGRESS REPORTS

The GRANTEE shall furnish to the COUNTY monthly progress reports, due by the 5th of each month, during the phases of construction. Upon completion of construction, a copy of the Occupancy Permit, issued by the local municipality, shall be furnished to the COUNTY. Fees associated with Occupancy Permits are not part of the Land Development & Construction Fee Waiver Program.

ARTICLE VI

SIGNAGE

Within sixty (60) days of the completion of the project and issuance of an Occupancy Permit, the GRANTEE shall erect and maintain on the site of the business operation a permanent sign acknowledging assistance from the COUNTY. The sign will state that the business was provided with financial assistance from the COUNTY. It will identify the land development and construction fee waiver program and the names of the Lackawanna County Commissioners and display the official county seal. The required signage may be incorporated onto any other sign(s) required as part of any additional financial assistance between the GRANTEE and any other public agency or financial institution.

ARTICLE VII

REFUND OF FEES

The GRANTEE shall refund to the COUNTY any overpayment as determined by the COUNTY.

The GRANTEE shall refund to the COUNTY the COUNTY'S reimbursement amount should the GRANTEE fail to adhere to the terms and conditions of this section as prescribed in this Agreement.

ARTICLE VIII

GOOD STANDING

In order to be eligible for the COUNTY Land Development & Construction Fee Waiver Program, the GRANTEE must be a company in good standing with the Commonwealth of Pennsylvania and be current on its federal, state, local and county taxes.

ARTICLE IX

VERIFICATION

The COUNTY shall verify the information provided by the GRANTEE prior to issuance of a check to the GRANTEE. The GRANTEE agrees to be available and shall provide all information requested by the COUNTY prior to COUNTY issuance of a check to the GRANTEE.
